# OPENING REMARKS



## **Eric Parrado Herrera**

Eric Parrado Herrera is Chief Economist and General Manager of the Research Department of the Inter-American Development Bank (IDB). Before joining the IDB, he was a professor of economics and finance at the ESE Business School of the Universidad de los Andes in Santiago, Chile. Mr. Parrado is a visiting professor at Oxford University and the Central European University, and member of the World Economic Forum's Global Future Council on Financial and Monetary Systems. He was the Superintendent of Banks and Financial Institutions in Chile (2014-2018) and Manager of the Chilean SWFs (2007-2010). He holds a Ph.D. in Economics from New York University.



## **Tao Zhang**

Tao Zhang is Deputy Managing Director at the International Monetary Fund. He is responsible for IMF operations in about 90 countries, as well as policy issues related to anti-money laundering / combating the financing of terrorism, climate change, fintech, gender, and statistics. He has extensive international economic expertise and policymaking experience, including as Deputy Governor of the People's Bank of China (PBOC) and IMF Executive Director for China. Earlier in his career, he spent many years at the PBOC in various senior roles and also worked at both the World Bank and the Asian Development Bank. He holds an M.A. and Ph.D. in International Economics from the University of California, Santa Cruz, California, as well as a B.S. in Electrical Engineering and an M.S. in Finance from Tsinghua University in Beijing.



## **Carmen M. Reinhart**

Carmen M. Reinhart is the Vice President and Chief Economist of the World Bank Group. She comes to this position on public service leave from Harvard Kennedy School, where she is the Minos A. Zombanakis Professor of the International Financial System. She serves on the Advisory Panels of the Federal Reserve Bank of New York and the International Monetary Fund. Previously, she was the Dennis Weatherstone Senior Fellow at the Peterson Institute for International Economics and Professor of Economics and Director of the Center for International Economics at the University of Maryland. Earlier, she was the Senior Policy Advisor and Deputy Director of the Research Department at the International Monetary Fund and held positions as Chief Economist and Vice President at the investment bank Bear Stearns. In 2018 she was awarded the King Juan Carlos Prize in Economics and NABE's Adam Smith Award, among others. She holds a Ph.D. from Columbia University.

## **Hal Varian**

Hal R. Varian is the Chief Economist at Google, Inc. He is also an emeritus professor at UC Berkeley in three departments: business, economics, and information management. Previously, he taught at MIT, Stanford, Oxford, Michigan and other universities around the world. Hal is a fellow of the Guggenheim Foundation, the Econometric Society, and the American Academy of Arts and Sciences. He received his B.S. degree from MIT and his M.A. in Mathematics and Ph.D. in Economics from UC Berkeley.



## **Erin Egan**

Erin Egan is Vice President and Chief Privacy Officer of Public Policy, leading Facebook's global privacy and data policy team. She collaborates with policymakers, regulators, advocates, academics, and other experts on issues related to privacy and data protection, ensuring Facebook's products and features reflect input from people around the world. She is deeply involved in legislative and regulatory efforts to address privacy, advertising, AI, and other data protection issues. Erin previously served as Facebook's head of US Public Policy, where she led federal and state public policy efforts. Prior to joining Facebook, Erin was a partner and co-chair of Covington & Burling's global data protection practice.



## Eric Gundersen

As CEO of Mapbox, Eric oversees product, business, and marketing. He started Mapbox to create tools that make location data powerful and available to everyone and previously co-founded Development Seed, a consultancy that developed open source tools for international development agencies and nonprofits to map the world. He holds a master's degree in International Development and a dual bachelor's degree in Economics and International Relations from American University.



## Parker Ence

Parker Ence is the CEO of Veraset, a leading geospatial data-as-a-service company. Parker and his team are passionate about providing the best mobile location and population movement data to support data scientists and innovators who are solving important problems in economics, public health, urban planning, advertising, and more. Parker has an eclectic entrepreneurial history, including running a healthcare insurance tech company in Texas and helping to launch machine learning APIs for matching job searchers while at Google. Parker received an MBA from Stanford Graduate School of Business.



## Pheabe Morris

Pheabe Morris is Senior Counsel with the Administrative Law Unit of the IMF Legal Department. She leads the procurement and technology and copyright practices and handles matters relating to the IMF's privileges and immunities, resolution of commercial disputes, data security, intellectual property rights, policy matters relating to staff employment, and administrative and ethical matters for the Executive Board. Prior to coming to the Fund, she practiced banking and finance law at a New York City law firm. She received her Juris Doctor degree from Columbia University School of Law and is a licensed attorney in the State of New York.



## Holly Krambeck

Holly Krambeck is a Program Manager in the World Bank's Development Economics Data Group. She founded the Development Data Partnership, a partnership between international organizations and companies, created to facilitate the responsible use of third-party data in international development. Prior to her current assignment, she was a World Bank Task Team Leader, responsible for a \$950 million portfolio of transportation infrastructure loans and technical assistance grants in East and Southeast Asia. Her technical assistance program helped transport agencies across different countries improve the efficiency and efficacy of their data collection, management, and analysis for decision making. Holly holds a Master of Science in Transportation and a Master in City Planning from the Massachusetts Institute of Technology.

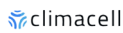
## Haishan Fu
